Please review and complete the attached Patient Health Record prior to your appointment. The Children's Health Record should be completed for all children under the age 18. Also complete a Children's Health Record for dependent children over the age 18 who are currently covered by a parent's dental insurance. All paper work should be signed by any patient 18 years of age or older.

Also attached is a Patient Consent Form. Please read this form then sign and date it. This is our HIPAA compliance form required by the Federal Government to inform all patients of how their personal health information can be used. Any questions regarding this form can be directed to our HIPAA Compliance Officer at your appointment.

College students covered by their parent's dental insurance should obtain a Student Status form from their college. This form needs to show the number of credit hours currently enrolled for.

Our office is a preferred provider for Blue Cross Blue Shield of Georgia dental insurance. We will gladly file any primary insurance claims. Deductibles and estimated co-pays are due at the time of service. Any difference in insurance payments will be billed to you and is payable in 30 days.

The Right to Choose

Exams: The dentists perform exams on a rotating schedule. Therefore, your examination could be performed by any of dentists. If you have a preference, please inform the hygienist. Otherwise she will have the scheduled dentist perform the exam.

Dental Work: If you need dental treatment, ie. crowns, fillings, extractions, etc., *you choose* the dentist to perform the procedure. Please do not feel uncomfortable, Dr. Whittle, Dr. Gay, Dr. Herring and Dr. Brown prefer that you make the choice that's best for you.

Dental Hygiene Appointments: We currently have seven (10) hygienists in our office to meet your dental hygiene needs. Please inform the receptionist if you have any preference.
